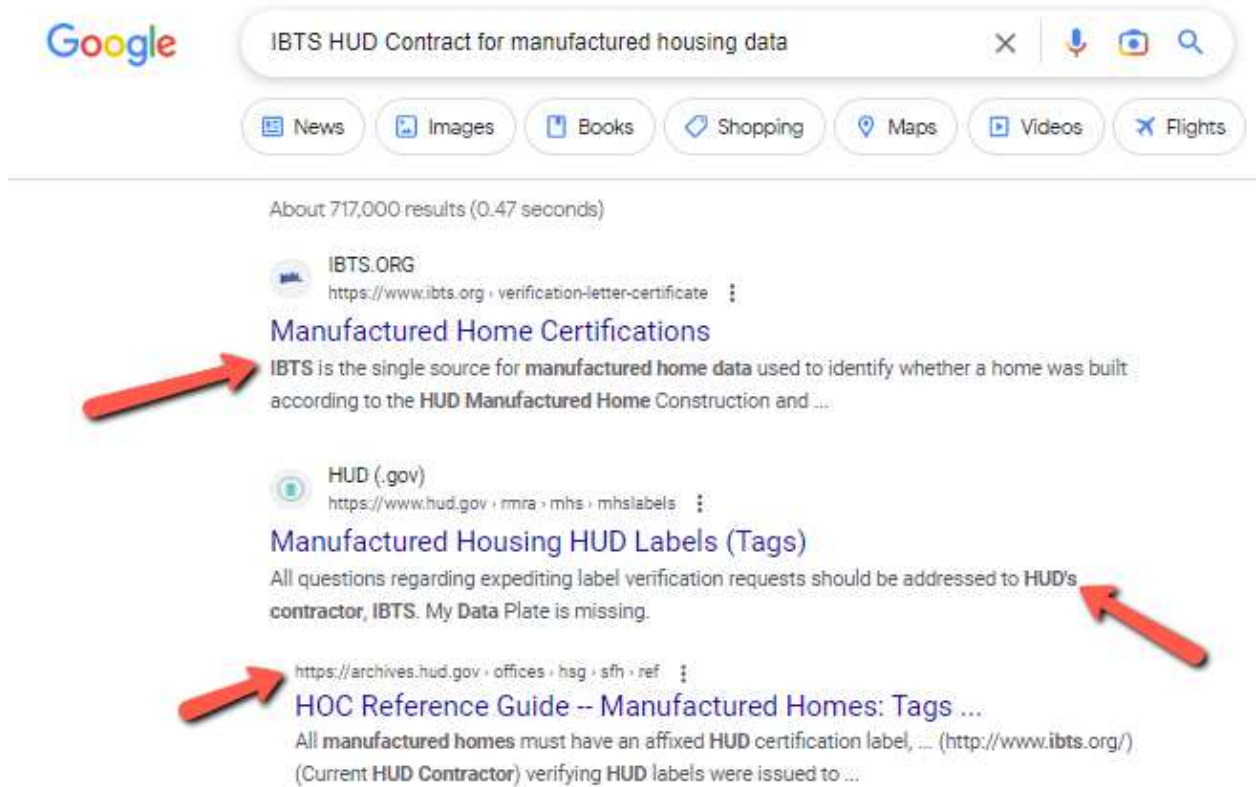


- 1) IBTS is HUD's contractor for gathering manufactured housing production and shipment data. Restated, HUD's data is generated by IBTS research.
