In the nearly two years of almost daily experience of this writer for *MHPProNews*, when an AI system provides useful but somewhat flawed responses, if it is presented in a follow up with facts that are difficult to dispute, AI will often (not always) admit its error and modify its result. That said, this was a once time question and Gemini's initial response. The question by MHPProNews is under the logo shown below. The response by Gemini is under its corresponding logo/image. Note that Gemini has stated in a prior Q&A (chat thread) that it can discern common typos, not unlike a search engine does. So modest typos caused by haste in typing found below are not of concern in generating a response, as Gemini's answer clearly illustrates.

That said, I did pull one suggestion from what you provided, edited it into the article, tweaked the headline and did some other additions and refinements.
