So, when we write about the problems associated with Frank Rolfe, Dave Reynolds, Havenpark, RHP, Yes, ELS, Berkshire and their brands, or whomever, several of those individuals have met me personally, and all of them would be among our platform's readers (though they routinely dislike our analysis and commentary). I've managed manufactured home communities, and have lived in them too as both resident and as management.

In my view, much of what you said is accurate, but you failed in that Common Dreams article to mention manufactured housing at all. Yet, you seem to be aware of some of the obviously negative issues in our industry.
