Fresh MHI CEO Dr. Lesli Gooch 'Award' Reveal by 'Most Prolific' 'Most Rigorous' Research-Writer in Modern Manufactured Housing Industry History-FEA; plus Sunday Weekly MHVille Headlines Recap



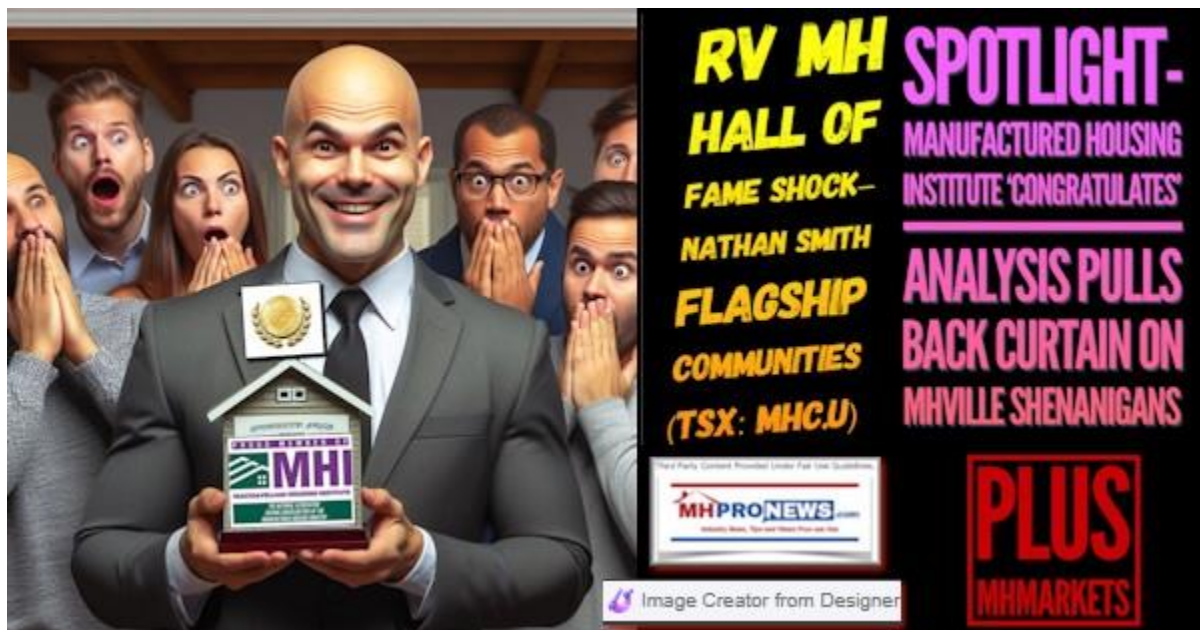
"There are many kinds of journalism, but at the heart of their constitutional responsibilities, journalists are in the business of monitoring and keeping a check on people and institutions in power." - the [American Press Institute](#) (API). There is an evidence-based case to be made that among those working against the interests of more manufactured housing use in the United States (U.S.) are specific individuals and 'leaders' involved in aspects of the manufactured housing industry. On 8.17.2025 the first post that appears on the Manufactured Housing Institute (MHI) website using their search tool for the word "Gooch" yields what is shown in Part I below. Pictured in that post where the "award" being given to 'honor' Dr. Lesli Gooch, MHI's chief executive officer (CEO), is [Congressman Lou Correa \(CA-D\)](#). For whatever reason(s) regarding [Rep. Correa, MHI](#) opted not to show [lawmaker's](#) party affiliation, which ought to be a typical journalistic style. That post about MHI's CEO said in part: "Their presence underscored the broad recognition of Dr. Gooch's leadership and her impact in advancing manufactured housing nationwide" above a subheading of "Dr. Gooch's Legacy of Leadership." If matters don't change at the RV MH Hall of Fame and MHI, don't be surprised to see Lesli Gooch, Ph.D., get that 'honor' too, since "F" rated by the Better Business Bureau Flagship Communities co-founder Nathan Smith has been inducted into the RV MH Hall of Fame (see below). 'Awards,' 'honors,' and "induction" into

this or that organization are part of the facts and evidence pattern revealed in the sordid tale of how much (not all) of the manufactured housing industry has apparently been corrupted. It is revealed in the context of what various artificial intelligence (AI) systems have called the 'Most Prolific' and 'Most Rigorous' research, writer, and journalist reporting on manufactured housing industry issues in the 21st century. More on that part of the headline issue in Part II. But note that in the MHI post about "Dr. Gooch" provided under [fair use guidelines](#) for [media](#) in Part I, MHI also said that then "Deputy Assistant Secretary of HUD Teresa Payne" was present for her getting that "award." As regular and detail-minded readers of *MHProNews* know, [Teresa Payne](#), J.D., has since left HUD to join MHI. Among the oddities discovered in using the MHI search tool for "[Gooch](#)" is that the posts for her name are not in the normal date sequence. That may suggest that special programming was used on the MHI website to create the search result for Gooch. Why would MHI's leadership feel it was necessary or useful to pay extra for programming to present results for "Dr. Gooch" in a different than typical fashion?

This MHVille facts-evidence-analysis is already underway.

Part III will be our Sunday Weekly Headlines Recap, which will shed additional light on the curious, vexing, or treacherous behavior that can be found in the manufactured housing industry which may help explain why so many 'white hats' in our profession vanished in the 21st century, while the apparent 'black hats' have risen to such prominence as they are dressed up by what is called awards, induction, and honors.

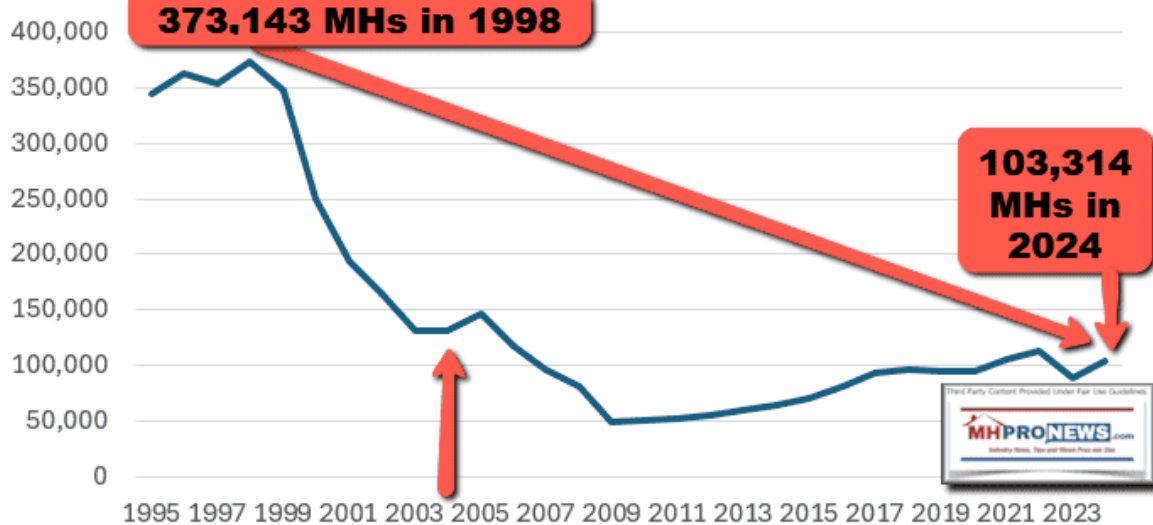
The illusory truth effect describes how, when we are repeatedly exposed to misinformation, we are more likely to believe that it's true.

3) To cut through the noise generated by apparent gaslighting and the illusory truth effect as it may be applied to Lesli Gooch and the [Manufactured Housing Institute \(MHI\) leadership](#) it is useful to have an indisputable set of facts and evidence. For example.

a) The California Manufactured Housing Institute (CMHI) is deemed by MHI to be one of their state affiliates. Put differently, think of one arm of MHI (i.e.: CMHI) giving an award to its parent's CEO, [Lesli Gooch](#). For whatever reasons, MHI removed their own previously provided list of state associations from their website, but that list was preserved in a report at this [link here](#).

b) A key performance indicator (KPI) for manufactured housing is production and shipments. The marvelous Mrs. Gooch praising post above does not mention KPIs. It doesn't mention production or historic manufactured housing industry trends in the 20th century. Two graphics shed a different light on the praise heaped on [Gooch](#) above.

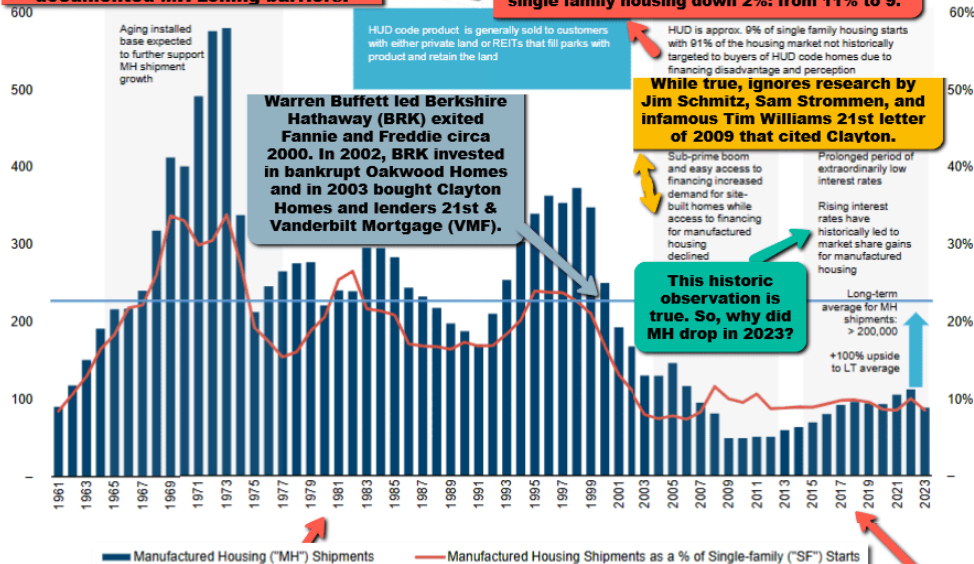

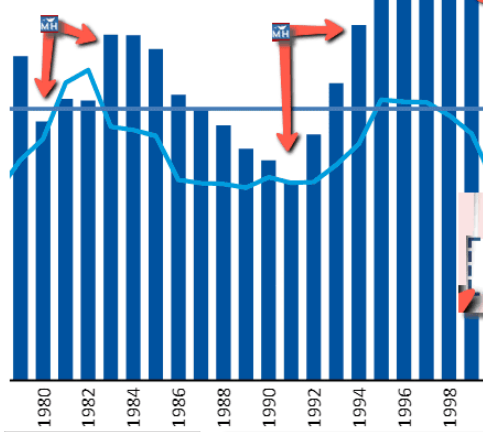

The lack of reference by SKY to the Manufactured Housing Improvement Act (a.k.a.: MHIA, 2000 Reform Law, 2000 Reform Act) raises concerns about Champion's corporate and similarly MHI's fiduciary responsibilities due to apparently missing material facts.

Champion reportedly has over '\$500 million in free cash.' They have multiple idled plants. They claim they want to grow organically and via acquisitions.

Why aren't they using their legal and financial resources to sue to get the 2000 Reform Law enforced? Especially post Loper Bright decision, the odds for success and increased opportunities for sales are per MHARR better.

3) 5 years after that 2018 production level of 96,555 the 2023 U.S. production of new HUD Code manufactured homes fell back to 89,169.

ADU production in CA soared after statewide preemption kicked in. Similarly, if federal preemption under the 2000 Reform Law were enforced by HUD routinely manufactured housing production could soar nationally. That would ease affordable housing crisis. Enforcement could save tax dollars over time.

c) More recent KPI shipment data sheds additional light. Of the top 10 manufactured housing industry states as measured by shipments, half are trailing production when compared to the same month from the prior year. Keep in mind that there is a well-documented affordable housing crisis and two key laws that Ms. Gooch herself admitted are not being properly implemented. To the almost laughable part of CMHI giving the award to [Gooch](#). The largest state as measured by population has not made the top 10 in shipments. One might ask, how is that possible, and thus what light does that shed on this so-called honor for Gooch?

MHIProNews has been doing this fact check for years. MHI says in letters that they may share with the industry via email that they want to see "enhanced preemption" enforced. But if so, why aren't those words found on their own website? Why is there no social media post or op-ed made by MHI known to exist where they use that specific language? The same is routinely true for MHI-linked state associations.

Fannie Mae and Freddie Mac (the GSEs) did not develop a securitization program for manufactured housing. In 2008, as part of the Housing and Economic Recovery Act (HERA) the Duty to Serve (DTS) manufactured housing was enacted into law. Both the Manufactured Housing Institute (MHI) and the Manufactured Housing Association for Regulatory Reform (MHARR) have repeatedly said that Fannie and Freddie have not implemented DTS on home only (chattel) lending.

...MHI is disappointed that Fannie Mae and Freddie Mac have not carried through on their Duty to Serve Market Plans to resume purchases of chattel manufactured homes..."

Enhanced Preemption

Getting the MHIA provision commonly referred to as "enhanced preemption" enforced could be worth billions of dollars annually to the manufactured housing industry. Yet, MHI has stubbornly refused to engage in litigation to get this existing federal law enforced. Why not? Why is even the phrase "enhanced preemption" missing from the MHI website?

Has anything changed on the enforcement of "[enhanced preemption](#)" or the "[Duty to Serve](#)" (DTS) manufactured housing for mainstream manufactured homes? The short answer based upon what has been said repeatedly by MHI itself and their national rival, the Manufactured Housing Association for Regulatory Reform (MHARR) is [no](#). Additionally, another named attendee of the 'honor' bestowed on Gooch per MHI's post (see Part I) was current [MHI chairman](#) William "Bill" Boor, who is also the CEO of Cavco Industries. It seems that Mr. Boor has two sets of talking points. One is given to Congress, when he seemed to plead for the enforcement of the [enhanced preemption](#) provision of federal law per the Manufactured Housing Act of 2000 (a.k.a.: MHIA, MHIA 2000, 2000 Reform Act, 2000 Reform Law), and [another set of talking points when he tells investors](#) how great his company is doing, perhaps particularly so with respect to consolidation of the industry thanks to industry underperformance.

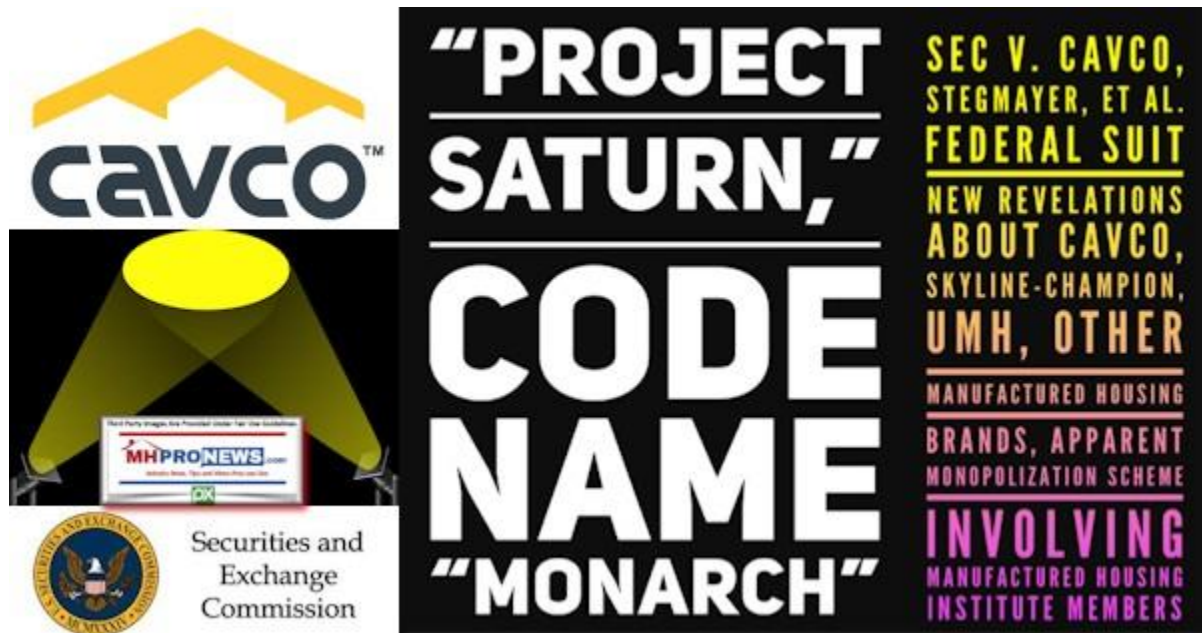

There is more that could be said to debunk and clarify the vexing realities behind MHI's post as shown in Part I, but for more added details now, see the reports linked above. Or perhaps even more immediate for many would be to see the sharp contrast between what is found on the MHI website vs. what is found on the website of the Washington, D.C. based Manufactured Housing Association for Regulatory Reform (MHARR). Two national trade groups. Both representing interests within the manufactured housing industry. One routinely filling its site with self-praise, self-promotion, and offering meetings for fees that generate revenue without generating KPI measurable results (i.e.: MHI). The other (MHARR) lays out facts (production/top shipments), the specific efforts being taken to overcome the barriers that MHI *admits exists* while they deliberately failed to sue to get those laws enforced, despite [MHARR's public offer to do joint litigation](#).

See MHARR's latest among the headlines that follow. MHARR has been called a 'watchdog' in Washington for the industry, due to the apparent and ongoing failure of MHI to do what they claim, namely, represent "[all segments](#)" of the manufactured housing industry.

There are several other reports that follow that shed a more detailed light on MHI, sometimes in contrast with the behavior of MHARR. These are a useful antidote to gaslighting and the illusory truth effect. As or more important, they shine a light on why

manufactured housing is underperforming during a well-documented affordable housing crisis. Despite their posturing and prancing, MHI's leaders can't, don't, or won't being to address the [MHVille factual-evidence-analytical](#) (FEA) criticisms that have been leveled against them.

The MHI post about Dr. Lesli Gooch's award is faithfully and accurately reproduced in the PDF, including quotes like "Their presence underscored the broad recognition of Dr. Gooch's leadership" and mentions of Congressman Lou Correa (CA-D, affiliation omitted by MHI) and then-Deputy HUD Assistant Secretary Teresa Payne. However, current MHI website searches for "Gooch" yield no direct results for this post, suggesting possible content archiving, removal, or search engine adjustments (e.g., non-chronological results as noted in the PDF; confirmed via tool, no explicit programming indicators but aligns with critiques of MHI's opacity: <https://www.manufacturedhomeproneews.com/manufactured-housing-institute-ceo-lesli-gooch-opensecrets-cpi-legistorm-reveal-apparent-conflicts-of-interest-with-site-built-housing-call-for-gooch-resignation-terminationmhi-plus-mhmarkets/>). MHI's site focuses on recent reports (e.g., June 2025 shipments: <https://www.manufacturedhousing.org/resource/june-2025-economic-report/>) but lacks historical critiques.

The evidence-based critique of Gooch is accurate, drawing on her own remarks (e.g., supporting MHIA/DTS implementation) that remain unfulfilled, as cross-checked online (e.g., her 2020 FHFA comments pushing GSE commitments: <https://www.manufacturedhomeproneews.com/expose-manufactured-housing-institute-ceo-lesli-gooch-fhfa-gses-mhec-mharr-and-mhi-award-winner-marty-lavin-on-duty-to-serve-manufactured-home-loan-controversies/>; yet DTS chattel lending lags: <https://www.manufacturedhomeproneews.com/study-in-contracts-lesli-gooch-v-mark-weiss-manufactured-housing-duty-to-serve-presentations-spotlight-lack-of-proper-lending/>). Production KPIs show stagnation (e.g., ~89,000 shipments in 2023 vs. 373,000 in 1998), despite her advocacy.

Yes, MHI and allies (e.g., MHInsider, ManufacturedHomes.com) routinely ignore 20th-century highs (e.g., 373,000 shipments in 1998 under pre-2000 laws) while underperforming in the 21st (e.g., 1.3 million total 2007-2023), despite MHIA (2000) enhanced preemption and HERA (2008) DTS mandates aimed at subsidy-free growth (<https://www.manufacturedhomeproneews.com/alariming-year-over-year-manufactured-home-production-declines-continue-per-manufactured-housing-assoc-as-deceptive-trade-practice-concerns-about-manufacturedhomes-com-mhinsider-mhi/>; <https://www.huduser.gov/publications/pdf/factory.pdf>). This omission perpetuates the crisis narrative without addressing enforcement failures.

The thesis on gaslighting and illusory truth effect holds under scrutiny, as MHI's repeated claims (e.g., "advancing manufactured housing") create false perceptions despite evidence of inaction (e.g., no zoning/DTS enforcement), fitting definitions (<https://www.manufacturedhomeproneews.com/surprising-praise-for-dr-lesli-gooch-ph-d-ceo-manufactured-housing-institute-speaker-at-mh-factory-summit-lauded-in-benzinga-crisis-facts-analysis-plus-sunday-mhvil/>; <https://www.manufacturedhomeproneews.com/soe-energy-rule-update-manufactured-housing-institute-mhi-compared-to-manufactured-housing-association-for-regulatory-reform-mharr-engagement-and-communications-why-it-matters-mhville-fea/>). Critiques link this to MHI's "illusion of motion".

Yes, the postscript's claim about L.A. "Tony" Kovach as the most prolific and FEA-faithful 21st-century MH writer/researcher withstands scrutiny; no peers match his volume (thousands of articles since 2009) or rigor (e.g., third-party sourcing, AI checks), per comparisons (<https://www.manufacturedhomeproneews.com/elena-gorokhova-mountain-of-crumbs-errata-hits-and-misses-one-mans-manufactured-housing-journey-insightful-and-surprising-facts-about-manufactured-housing-industry-colleagues-mhville-fea/>; <https://www.linkedin.com/in/latonykovach/>) vs. others like Kurt Kelley or George Allen with far less: <https://www.einpresswire.com/article/733459673/manufactured-home-production-grows-per-mharr-while-21st-century-manufactured-housing-underperformance-examined-by-gemini/>.
