Washington, D.C. – Today, ahead of the markup on the landmark bipartisan housing legislation in the Senate Committee on Banking, Housing, and Urban Affairs, crossindustry stakeholders and local elected officials are voicing their support for the bipartisan *ROAD* to Housing Act:
