The AI response is shown a bit further below. That is provided as a backdrop or framing for the headline topics. There are any number of times that an individual may reflexively believe that they are unable to impact big challenges. What is a given is that without a serious effort, changes for good or ill don't happen. JP Morgan Chase was contacted, and they responded. Congressional Representatives Maxine Waters (CA-D) and Mike Flood (NE-R) were contacted about the ROAD to Housing Act 2025. Lutheran Church linked Thrivent Financial was also contacted about that topic as well as their curious move to increase their stake in publicly traded Champion Homes (SKY). Those items will be systematically provided below in Parts I, II, and III of this Sunday Weekly MHVille Headlines in Review.

But first up in this facts-evidence-analysis (FEA) article are those examples from artificial intelligence in response to the input-inquiry above about women and men who have made an impact on some aspect of our society. #### Political contributions

- George Washington (1732–1799): A founding father and the first U.S. president, he led the Continental Army to victory during the Revolutionary War. His leadership in establishing the presidency and the two-term limit set vital precedents for the new American government.
- Abraham Lincoln (1809–1865): As the 16th U.S. president, Lincoln preserved the Union during the Civil War, issued the Emancipation Proclamation, and ultimately abolished slavery with the passage of the 13th Amendment.
- Frances Perkins (1880–1965): The first woman to serve in a presidential cabinet, as Secretary of Labor under Franklin D. Roosevelt. She was a driving force behind the New Deal, helping to pass groundbreaking legislation like the Social Security Act and the Fair Labor Standards Act.
- Franklin D. Roosevelt (1882–1945): The 32nd U.S. president, who led the country through the Great Depression with his New Deal programs and later guided the Allies during World War II.
- Shirley Chisholm (1924–2005): The first African American woman elected to the U.S. Congress, serving from 1969 to 1983. In 1972, she was the first African American candidate for a major party's presidential nomination.
- Sonia Sotomayor (b. 1954): The first Hispanic and Latina Supreme Court Justice.
   Appointed in 2009, her rulings have significantly impacted cases related to the
   Affordable Care Act and marriage equality.

#### Social contributions


- Harriet Tubman (c. 1822–1913): A formerly enslaved woman who became a "conductor" on the Underground Railroad, leading dozens of people to freedom. She also served as a Union spy, nurse, and cook during the Civil War.
- Susan B. Anthony (1820–1906): A leading figure in the women's suffrage movement, she tirelessly advocated for women's right to vote. The 19th Amendment, which granted women suffrage in 1920, is often referred to as the "Susan B. Anthony Amendment".

- W.E.B. Du Bois (1868–1963): A sociologist, historian, and civil rights activist. He cofounded the NAACP and was a leading intellectual voice addressing racial inequality in the 20th century.



#### Part IV MHVille Headlines in Review

As the MHProNews disclosure document reflects, visits and pageviews in September 2025 exceeded 1.8 million visits and over 6.454 million pageviews as multiple AI confirmed. There has been a sharp rise in visitors in month-to-date October over August 2025. Compared to CNN, the New York Times, Fox News or others, that's small.

In July 2025, Fox News Digital had 142.2 million monthly unique visitors, CNN.com had 90.9 million, and NYTimes.com had 67.6 million. These figures represent average monthly total digital unique visitors for each news outlet's online platforms.

But compared to the Manufactured Housing Institute (MHI), per SimilarWeb (as MHI has repeatedly declined publicly documenting their visitor and engagement data), MHProNews has multiple times MHI's monthly visits in a fraction of a day. In September, per known data, MHProNews exceed the visitors and pageviews of the retail sites in our industry. Why do such facts matter in this context? Because outreaches by MHProNews to \$193 billion-dollar Thrivent, or multi-trillion-dollar in assets JP Morgan Chase, or to various lawmakers is reaching a wider audience than ever before.

Who answers with what and how is potentially insightful. The fact that someone answers at all, even with a "no comment," reflects a professional - and arguably prudent on the part of the respondent's - media contact to the audience that gathers here to read reports like this one.

Manufactured housing currently has two active national professional trade groups. The Manufactured Housing Association for Regulatory Reform (MHARR) and MHI. MHI is pushing a flawed bill in Congress.


When this platform uses AI, among the routine points stressed is that a statement be supported by facts and evidence. While imperfect, that infographic above has correctly laid out an evidence-based case for what manufactured housing matters.

But to the point of contacting Thrivent or JP Morgan Chase, or members of Congress, there is manufactured housing done correctly and manufactured housing done incorrectly. There are correct ways to invest in manufactured housing, and arguably incorrect ways to invest in this industry. Those points would be true of most every profession, not just manufactured homes.

No one that reads *MHProNews* is thinking that we or our MHLivingNews sister site follow the <u>AP Stylebook</u>. We do not. That's not a slur against the <u>left</u>-leaning AP. It is simply a statement of fact. Slowly, over time, in order to better inform our steadily growing numbers of readers, this platform moved from USA today style news briefs from a dozen or more years ago, to fewer, longer, more detailed, and interconnected facts that help paint a picture. Even accurate facts can be used in a misleading faction, as several MHI linked items reflect. As or more troubling is the point that organizations that ought to know better are producing information that some of their own executives surely must know are false when they are published. Some examples are warranted.

Three different annotated screenshots that span several years illustrate that last point. The dates each of those images were fact-checked and uploaded by MHProNews for publication begin to reflect the point that MHI is at best inconsistent with their information. Yet they call themselves an "institute." *Oxford Languages* on this date defines an institute as follows: "a society or organization having a particular object or common factor, especially a scientific, educational, or social one."




Site fees or "lot rent" in some cases are jumping at a far higher rate than MHI claims. Some of their own member's research data indicates a faster rise in site fees than what they questionable report as 3 percent. Some of MHI's publicly traded firm's IR reports contradict this claim too. That noted, there are about 22 million living in pre-HUD Code mobile homes as well as post-HUD Code manufactured homes.



Sadly, as this illustration fact-check reflects, there are many 'fact claims' made by MHI that do not stand up to close scrutiny. Several of their members have 'black hat' reputations. It is routinely better to buy or do business with an independent than several of their 'major' brands.

The reason *MHProNews* did each of those annotated screen captures (among hundreds of others) at those points in time was precisely to illustrate the errors in MHI's claims. How is publishing inaccurate information fulfilling the definition of "institute" as:

"a society or organization having a particular object or common factor, especially a scientific, educational, or social one."

As multiple reports in the headlines for the week in review will reflect those errors above, while vexing, are modest compared to the facts, evidence and patterns of behavior that emerge when MHI and several of their leading members are carefully examined.

MHProNews and our MHLivingNews sister site have been making the evidence-based case for years that MHI does not behave in the ways that a normal trade association ought to function. If someone takes merely a superficial look at MHI, it may seem 'normal.' But as one looks at the details, the patterns of behavior, and then one adds in the analysis by multiple AI systems that examine those facts, what emerges are insights like the one Copilot delivered in that report linked immediately above. Copilot said that MHI's email to their own members fit the definition of 'lie, false, and misleading.' Did MHI respond to that AI finding? No. More on that in the postscript.

As *MHProNews* has said, not every MHI member is problematic or corrupt. Not every firm that is a member of an <u>MHI linked state association</u> is problematic.
