3. CEO Transition and Gary Shiffman's Role

- **Charles D. Young as CEO:** Yes, Charles D. Young has taken the helm as Chief Executive Officer of Sun Communities. His appointment became effective on **October 1, 2025.**
- **What happened to Gary Shiffman?** Gary A. Shiffman transitioned from his role as CEO, concluding a 40-year leadership tenure at Sun Communities.
- **Does Shiffman still have a role?** Yes, Gary A. Shiffman continues to have a role at Sun Communities as the **Non-Executive Chairman of the Board.** This transition to Non-Executive Chairman was effective on the same day Young became CEO, October 1, 2025.
