1. Factually Inaccurate or Unsupported Statements?

Claims about industry production declines (e.g., ~100,000 units/year for a decade), HUD's historical knowledge of affordable housing barriers, and internal MHVille issues (e.g., greed post-1998) align with documented trends. Stoller's paraphrased headline concepts (e.g., "oligopoly power starts in our minds," data coercion) are explicitly disclosed as such and tied to his work.

Evidence: PDF search for "Matt Stoller" yields pages 1, 8, 57, 93-94, confirming attributions without alteration. This fidelity enhances credibility for readers navigating MHVille's opaque data ecosystem, where consolidators (e.g., Clayton Homes) control ~50% of production per SEC filings.

2. Various Quotes and Sources Properly Documented?

Facts: Yes, all quotes and sources are properly documented with fair-use disclaimers, page-specific attributions, hyperlinks, and context. Examples include Stoller's full email excerpt (page 8), MHI website pulls (pages 15-27), and investor docs (e.g., Flagship Communities pitch, page 5).

Evidence: PDF search for "quote" highlights pull-quotes from Stoller (pages 55, 93) with direct ties to his Substack.
