Logically, this sidesteps the "best case": MHIA's enhanced preemption (42 U.S.C. § 5403(d)) empowers HUD to override discriminatory zoning <https://www.govinfo.gov/content/pkg/CHRG-112hhrg75068/html/CHRG-112hhrg75068.htm>, yet Florida shipments lag (down 5% Aug 2025 <https://manufacturedhousingassociationregulatoryreform.org/manufactured-home-shipments/>).
