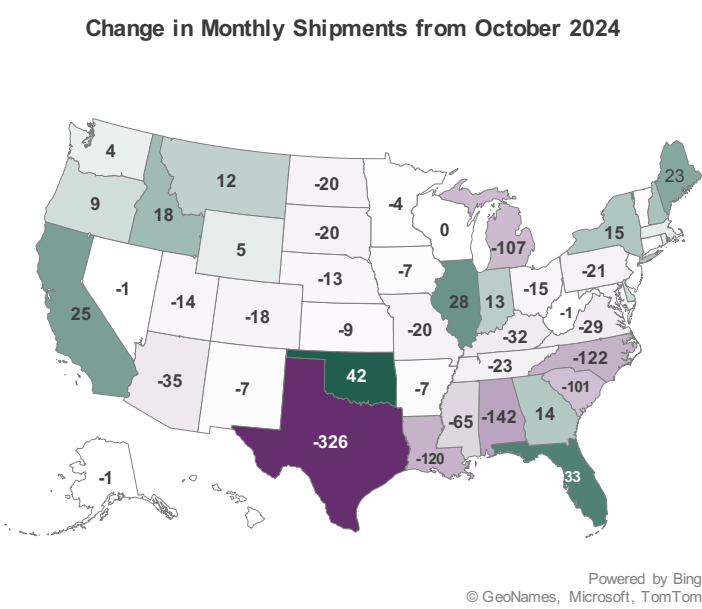

MHProNews notes: there is no apparent total production history data on CrossMod (TM) homes even though MHI, Clayton Homes (BRK), Champion Homes (SKY), and Cavco Industries (CVCO) have been promoting such homes since 2017. The lack of data begs the question: why are they promoting a product that may be undermining total HUD Code production and may only have an estimated 200 (+/-) total units produced since launched?

KEY FINDINGS

MANUFACTURED HOME PRODUCTION

- 9,260** Manufactured homes produced in October 2025. This month's production is -9.8% lower than a year ago (10,263 homes in October 2024), and 6.1% higher than last month (8,726 homes produced in September 2025). No FEMA units were produced this October, making the fiscal year total 169 homes.
- 88,735** Manufactured homes produced year-to-date. Through October 2025, production is 1.3% higher than a year ago (87,639 homes produced through October 2024 YTD).
- 151** Active homebuilding plants, operated by 39 corporations.

MANUFACTURED HOME SHIPMENTS

- 9.9%** Decrease in monthly manufactured home shipments year-over-year (9,267 homes shipped in October 2025 compared to 10,288 homes in October 2024). Month-over-month, shipments increased by 6.3% (8,720 homes in September 2025).
- 1.3%** Decrease in total manufactured home shipments to date year-over-year (88,744 homes shipped through October 2025 YTD compared to 87,640 homes through October 2024 YTD).
- 96,412** Seasonally Adjusted Annual Rate of Shipments (SAAR) in October 2025. SAAR is -10.1% lower than a year ago (107,275 shipments) and 4.7% less than last month (101,165 shipments).

PRODUCT MIX & GEOGRAPHIC BREAKDOWN

- 41:59** Product mix of single-section (40.9%) and multi-section (59.1%) shipments in October 2025. Year-to-date, 37,305 single-section homes have shipped, a -2.8% decrease from October 2024 YTD. To date, 51,439 multi-section homes have shipped, a 4.4% increase year-over-year.
- 12.5%** Market share of the top 3 geographic divisions for October 2025 shipments, including the New England (213 homes and 2.3% of total), Pacific (559 homes and 6% share), and Middle Atlantic (384 homes and 4.1% share).

Chart E1. Monthly Shipment Comparison

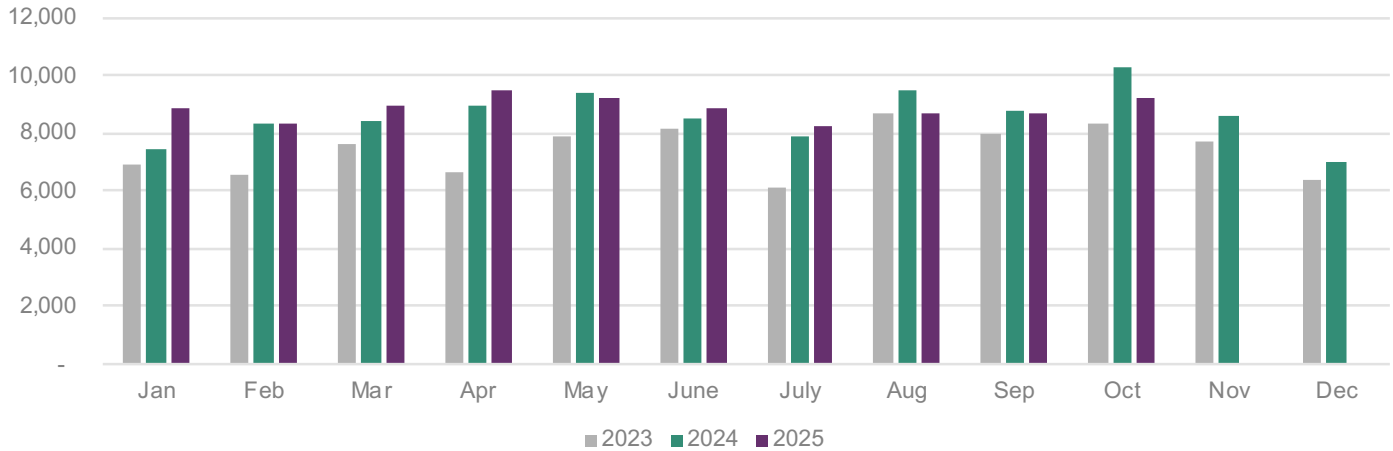

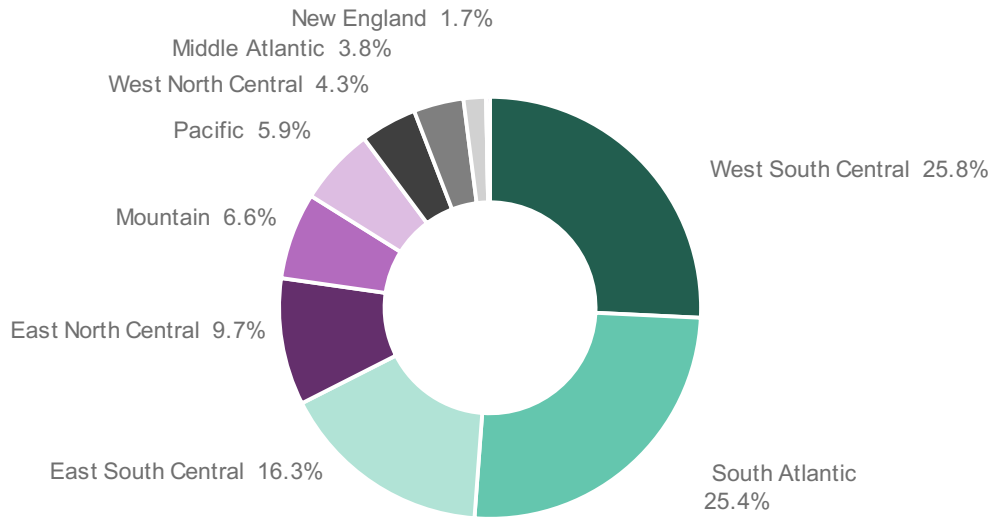

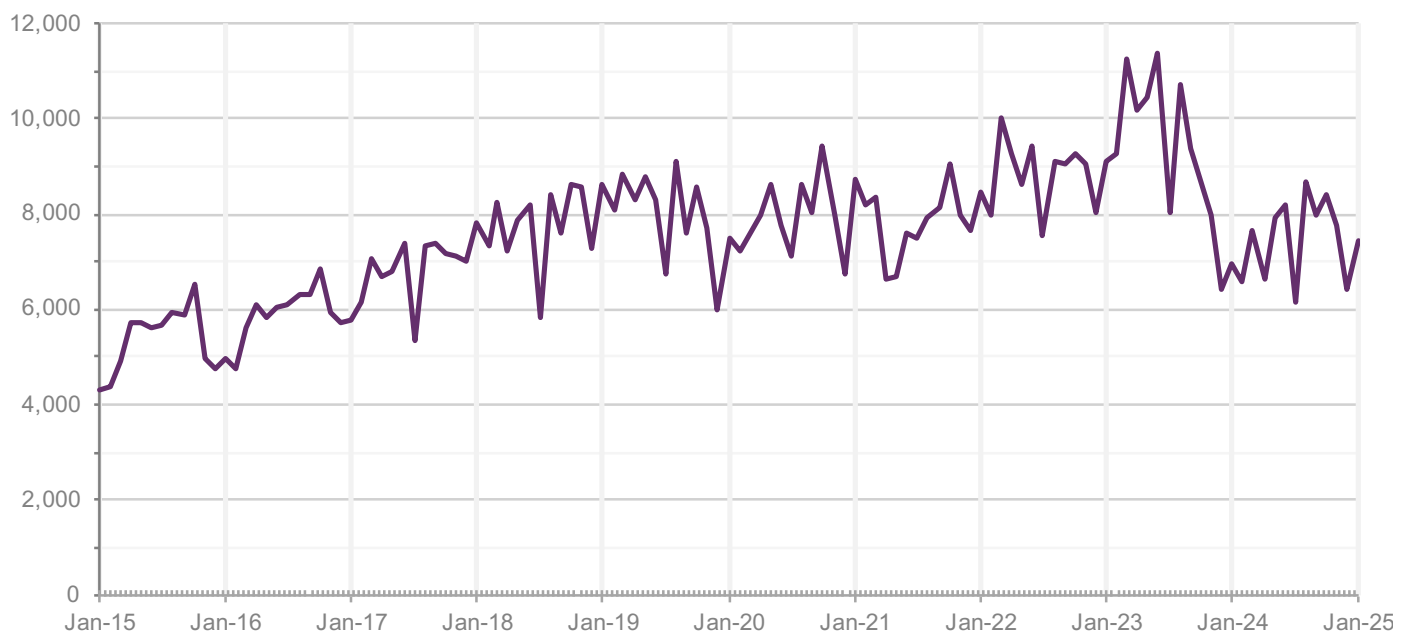
